

The Boneyard Dog Park

Rules and Regulations

The Ossian Boneyard Dog Park is open from dawn to dusk for registered key holders only. Under no circumstances will the park be in use before 7am or after 10pm. The maximum number of dogs allowed in the park area at any given time is 15. Please limit your visit to one hour during times of peak use.

- A dog park membership is required to use this facility. Registration information is available at the Ossian Town Hall.
- **Always keep an eye on your dog. Never leave your dog unattended.**
- Dogs known to exhibit vicious, fierce, aggressive, or dangerous behavior are not permitted in the park. If your dog becomes unruly or aggressive toward other dogs, you must leash your dog and exit the enclosure.
- Always clean up after your dog. It's the law. Containers are available in the park for this purpose. Please bring your own bags.
- Female dogs in season are not permitted in the playground and should not be brought to the park.
- Dogs, owners and users creating a disturbance or violating rules must leave the playground if requested by law enforcement personnel, town personnel, or other designated agents. Misuse of the park or allowing nonregistered pets in will cause the forfeiture of your key and no refund will be issued. Individuals failing to comply with the posted rules are subject to citation, expulsion or arrest, as well as dog(s) impoundment.
- Excessive barking is prohibited.
- No more than three dogs per handler are allowed at a time.
- Puppies under four (4) months of age are not permitted in the playground. Puppies are not fully vaccinated, and are vulnerable to disease and injury.
- Dog handlers must be 16 years of age or older. Children under 16 years of age must be accompanied by an adult.
- Dogs may not be left unattended or out of sight range or voice command.
- **Dogs must be on a leash** until safely inside the playground enclosure (fence).
- Please remove pinch (prong) collars and spike collars from dogs before entering the park, other dogs can be injured while playing.
- No animals other than dogs are permitted in the dog park. No wolves or wolf hybrids allowed.
- Do not bring glass containers to the facility.
- Do not bring food (people food, dog food or dog treats) into the playground. Many owners do not feed treats and some dogs may be allergic. Food may also cause aggression.
- No tobacco products in or around the park. Cigarette butts and food wrappers are unhealthy for dogs.
- Maintenance needs of the site will vary based on weather and use. You are asked to vacate the playground during maintenance activities.
- Dogs should receive year-round heartworm prevention treatment.
- Professional dog trainers shall not use the park to conduct their business.
- **Do not open the outside gate if the inside gate is open.**
- Owners must keep their dog(s) leash on their person at all times to be able to quickly regain control over their dog.

Be Aware of Risks

The Town of Ossian strives to provide a fun, safe environment for you and your dog. However, by using this facility you agree that you understand and assume all responsibility and liability for the risks of unleashing your dog in the facility.

Potential risks include, but are not limited to:

- Infectious diseases such as rabies, kennel cough or Lyme disease.
- Dog theft or unlawful capture by other people
- Dog escapes over or under fences.
- Plants and/or water sources in the park that may be poisonous to dogs.
- Park vegetation that may have burrs or seed that could get tangled in a dog's coat or lodge in a dog's feet, ear, or eyes.
- Mosquitoes, ticks, chiggers, fleas or other insects that may be present.
- Dog fights, dog bites and injuries to humans and other dogs.
- Wild animals in the parks such as skunks, raccoons, or stray dogs, all of which might injure or infect your dog.
- Young children are easily knocked over or trampled by running dogs.
- Herding dogs may nip at children while attempting to round them up.
- This is the dog's parks. There are plenty of other parks and playgrounds where children can be socialized. Not all dogs are child-friendly. Never allow your child to approach or pet a dog without the owner's presence and approval.
- **Parents:** If you do bring your children into The Boneyard Dog Park, please teach them how to behave with animals and what to do in an emergency:
Never run! Be sure to hide face and tuck arms and legs into body. Curl up in a ball, face down on hands and knees. Be as still as possible. Wait for help or until the dog has left.

In order for a bite to be defined as a bite – it must break the skin and must have been caused by oral contact (not a nail scratch).

A dog bite to a human or another animal **must be reported**. The biting animal will be quarantined for ten days to ensure it is healthy and does not pose a rabies risk. If the bite happens while inside the Boneyard fenced playground the dog will be considered legally restrained at the time of the bite. If a bite happens while at the park:

- Immediately secure the biting dog and the victim dog. Leash them and keep separated.
- Any wounds should be washed immediately with clean water.
- Owners of dogs involved should exchange names, addresses, and telephone numbers
- Local law enforcement should be called to take a bite report and enact quarantine.
- Owners should then take their dog home or to a veterinarian for necessary medical care. If a bite has occurred to a person, consult a physician.
- Dogs that have bitten while at The Boneyard Dog Park will not be allowed to return.

****The Boneyard is not staffed or supervised by any agent or employee of the Town of**

Ossian. Users therefore are required to abide by posted rules and etiquette at all times while on the premises. **

Dog owners and individuals accompanying them use the facility entirely at their own risk and that of their dogs. You will be required to complete a Waiver of Liability form before you are issued a park key. Owners are responsible and liable for the actions and behavior of their dogs at all times. The Town of Ossian does not assume liability for loss, damage, or any kind of injury sustained by any human or dog while using The Boneyard Dog Park.

It is important to familiarize yourself with pertinent Town Ordinances that apply to this playground as well as parks and park facilities in general.

Recommendations

- Be patient. Both entry gates to the park should never be open at the same time.
- Ensure all gates close behind you. Check all entrances before unleashing your dog.
- Remove your dog's leash inside the double-gated holding pen. Be sure gate area is not congested with excited dogs ready to pounce on your dog. Enter the area, close gate and move your dog away from the entrance.
- Dogs should receive year-round heartworm prevention treatment.
- Have drinking water readily available for you dog before and after exercise. You must provide your own water and bowls.
- ALL dogs benefit from guidance and structure. Basic obedience training is a must for safety, and a well-socialized happy dog. This is one of the best things you can do for you dog – and your family and friends.

Final Notes

Maintenance crews will conduct turf care and other site work as the need arises. Please allow them to complete their tasks to ensure the site meets expectations. You will need to vacate the play area while this work is in progress.

For practical reasons, snow removal will NOT take place during the winter months. Mother Nature will guide site use during snow periods.

Please retain this information and ensure that family members and friends who accompany you are aware of the rules, regulations, recommendations and risks that apply.

Waiver and Release

Please read this form carefully and be aware that in consideration for permission to use these facilities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your dog might sustain as a result of participating in any and all activities connected with and associated with use of these facilities and the surrounding areas.

I hereby acknowledge that I have voluntarily applied to participate and use with my dog(s), The Boneyard Dog Park and Off-Leash play areas owned and operated by the Town of Ossian. I understand that the act of unleashing my dog and being physically present within the parks necessarily involves risk of injury to me, persons that accompany me, other people using the park, my dog(s) and other dogs. I understand that the aforementioned risks are entirely my responsibility and I expressly assume that responsibility knowingly and voluntarily. When this Waiver and Release refers to my dog(s), it includes me whether or not I am the legal owner of the dog, since I am the person responsible for the dog while using the park.

I understand that the permit/license system is not established to guarantee that dogs in the park are safe or healthy. I also understand that dog activities are intended to provide a fun and rewarding experience for a dog and its owner/handler. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including death, to the dog, its owner/handler or other persons or animals. I further understand that dogs, irrespective of their training and usual past behavior or characteristics, may act or react unpredictably at times based upon instinct or circumstances, and that not all hazards and dangers associated with dog activities can be foreseen. I agree to assume the risk of any injury, to me, any individuals (including children) that may accompany me in the park, and my dog(s). I understand that this risk may result from fierce, aggressive, vicious, and dangerous dogs which may be present in the parks.

I further understand and assume the risk that not all dogs in the park may have been vaccinated for distemper parvo, or rabies, all of which could result in injury to me, any individuals (including children) accompanying me, and my dog(s). I also understand that there are certain inherent risks including the propensity of a dog to behave in dangerous ways. Additional risks include, but are not limited to: The inexperience or irresponsibility of a dog owner/handler, the inability to predict a dog's reaction to sound, movement, objects, persons or other animals; dog fights, dog bites, and injuries to humans and other dogs; dog theft or unlawful capture; dogs escape over or under fences; plants in the area that may be poisonous to dogs or people; mosquitoes, ticks, chigger, fleas or other insects may be present; and wild animals such as skunks, raccoons, opossums, or stray dogs that could be present in and around the park, as well as all other circumstances inherent to dog(s) and/or outdoor activities. I knowingly and voluntarily accept responsibility for all of these risks in exchange for the privilege or use of The Boneyard Dog Park.

It is my understanding that no agents or employees of the Town of Ossian will supervise the park at any time and I therefore expressly assume responsibility for all risks associated with the park as well as fixture and equipment that may be located there in an unsupervised manner.

By signing this Waiver and Release and using the park, I fully release and discharge the Town of Ossian and their employees and agents as well as any private citizen volunteers as park stewards which have been sanctioned by the Town from any claims, demands, damages, rights of action, present or future, known or unknown, anticipated or unanticipated, resulting from, or arising out of, my use or intended use of the park. I fully and forever release and discharge the Town of Ossian and their employees and agents as well as any sanctioned volunteers from any and all negligent acts or omissions with regard to the park and intend to be legally bound by this Release. I assume sole responsibility for, and agree to indemnify and save harmless the Town of Ossian their employees and agents and volunteers of each for any damages from bodily injury, death, or damage or loss to property including legal and expert witness fees caused by the previously described parties.

I HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND UNDERSTAND ITS CONTENTS. I HAVE ALSO RECEIVED A COPY OF THE DOG PARK AND OFF-LEASH AREA RULES AND REGULATIONS AND AGREE BY AFFIXING MY SIGNATURE BELOW TO COMPLY WITH THOSE RULES AND WILL ENDURE THEIR COMPLIANCE WHILE USING THE PARK. MY SIGNATURE CONFIRMS THAT I AM ALSO NOT AWARE OF ANY INCIDENTS IN WHICH MY DOG HAS SHOWN AGGRESSIVE, FIGHTING OR BITING BEHAVIOR TOWARDS OTHER ANIMALS OR PEOPLE.
